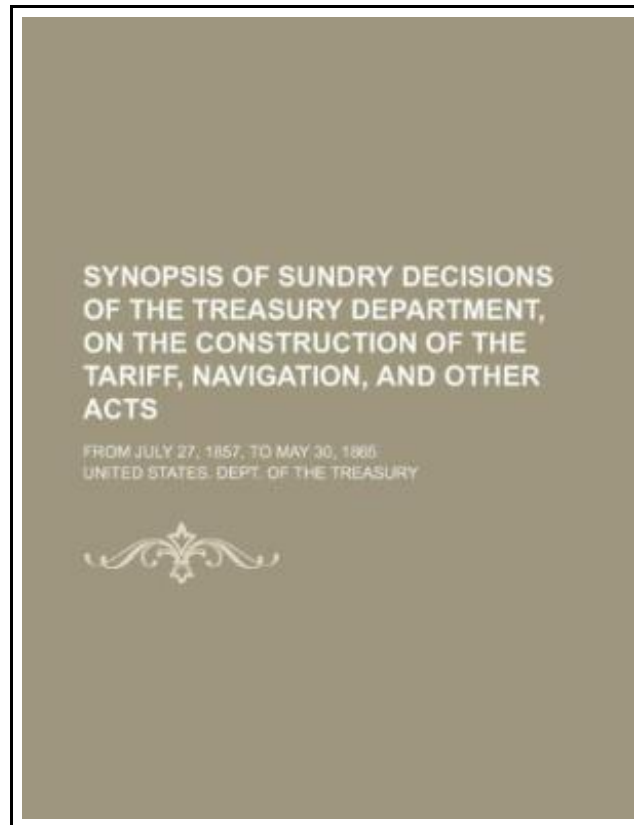

Sumners Co. from your assessment of duty at the rate of 30 per cent. as glass, cut, under schedule B of the tariff of 1857, on certain goblets imported by them. The appellants claim entry of the articles in question at the rate of 24 per cent. under the classification of manufactures, articles, vessels and wares of glass, or of which glass shall be a component material, not otherwise provided for, in schedule C. The sample submitted to the Department of the merchandise in question is a plain glass goblet, the bottom of which is smoothed by grinding, or, in other words, punted. This...
